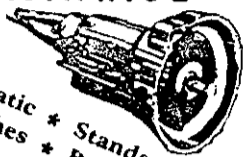

According to District Attorney Mike Little, the Texas Court of Criminal Appeals has denied the first appeal of the 1997 murder conviction of Robert Brice Morrow. The Liberty man was convicted of the brutal 1996 murder of Lisa Allison. The 20-year-old college student had been spending Easter vacation at home with her family, when she was abducted from a local car wash and her body was later found floating in the Trinity River. Morrow was sentenced to death in the 253rd District Court of then-presiding Judge W. G. "Dub" Woods. This first of many possible appeals in the process is automatic in every death penalty case, but, Little said with this denial, Robert Morrow is now one step closer to the lethal injection chamber.

Erwin Watson was working in his barn off CR. #2107 in Moss Hill around 11 a.m. yesterday when the loader he was using caught fire. The fire quickly spread, destroying the barn and came within 50-feet of a neighbor's home before being extinguished by firefighters from Hardin, Tarkington, Hull-Daisetta and Cleveland. Mr. Watson said the loader, the barn and its contents were a complete loss.

The Liberty County Federal Emergency Management Agency Board has secured \$38,861 in federal funding to supplement local emergency food and shelter programs. According to Liberty County FEMA Board Chairperson Tracy Pegues, organizations that apply for a portion of the funds must be public or private voluntary non-profit, non-discriminatory groups or government units, with an accounting system and a demonstrated ability to effectively assist those in need of food and shelter. The deadline to apply is January 31st, 2000.
